Located in Maryland, our licensed and accredited Harford County program for men and our Charlotte Hall program for men and women provide individualized inpatient and co-occurring disorders treatment for adults struggling with substance use.

Designed to meet the specific needs of each individual, our program staff includes medical professionals, a counseling team led by master's level clinicians, and peers with experience managing substance use and mental health disorders.

Maryland Medicaid and most commercial medical insurances are accepted. The Harford County program also accepts Delaware Medicaid.
