At our York Methadone Maintenance location, we combine methadone maintenance therapy; individual, group, and family counseling; relapse prevention; and support groups to provide the most effective form of opiate addiction treatment possible.

Medication Assisted Therapy for Opiate Addiction

Methadone is a synthetic narcotic agent that is used legally as both a pain medication and a blocking agent for the effects of heroin and other opiates, including OxyContin®.

Methadone is used to treat narcotic addiction by suppressing withdrawal symptoms for 24-36 hours. Individuals who are prescribed methadone for treatment of heroin addiction experience neither the cravings for heroin or the euphoric rush typically associated with the drug.

Methadone treatment is not a cure for heroin addiction but has been called the most effective treatment method for opiate addiction. When combined with behavioral therapy, medical care, and support groups, methadone offers the best chance for long-term recovery from heroin/opiate addiction.

Medication Assisted Therapy Outcomes

MAT is a proven, effective option for many individuals struggling to recover from opiate addiction. This treatment method offers individuals a reprieve from the physical symptoms of addiction and an opportunity to focus on the support programs and ongoing counseling crucial to leading a healthy, productive journey of recovery.

Clients enrolled in Pyramid Healthcare's MAT program will meet with a nurse and/or physician at the facility briefly every day to take a prescribed dose of medication and participate in random, mandatory urine screens under supervision to assure their drug-free status. Once clients are stabilized and consistently meeting program requirements, daily attendance requirements can be reduced.

Clients are also required to meet with a counselor, nurse, and/or physician to address their individualized addiction, recovery, and medical challenges and goals. Clients requiring additional, extensive counseling may be referred to intensive treatment and self-help group settings inclusive of Narcotics and/or Alcoholics Anonymous.
